What will change is that I will go over every invoice to make sure we are receiving the services we pay for.



We must have our audit completed on time. I have spoken with our accountant Chuck Kirblick and was very pleased with that conversation. I was previously told we had a contract with him that was irreversible. Mr. Kirblick informed me that all we had was a letter of engagement and he was willing to refund us the funds already paid minus expenses for time put into it. I was pleased with his response and decided to allow him to complete the 2002 audit for which we have already paid one half of the \$5,000.00 fee.

I will give you a bottom line number in future issues of this newsletter so you will know if we are spending under or over budget on an up to date basis.
