Fine Food for Hungry Thoughts - Part XIII Naim Nagi

Cheddar's Casual Café

Where will you go in 15 minutes from Royal Park and served in 15 minutes for a hot Lunch under \$10? Try Cheddar's Casual Café.

It is one of those unassuming places that you drive by a hundred times but never notice and frankly I did stumble into Cheddars by chance which turned out to be a pleasant surprise.

Located just one blocks west of University Drive on the north side of Commercial Blvd, Cheddar's Casual Café is unexpectedly a large eatery divided into many sections from a bar to booth seating and a big outdoor covered patio dinning area.

It has the feel of a mom and pop style enterprise but is actually part of over 60 Cheddar's restaurants nationwide with only three in Florida; the other two are in Brandon and Clearwater.

The hostess explained that they pride on wholesome American food which is made-from- scratch. Most dishes are under \$10 and there is plenty of choices for example; The Appetizers:

Santa Fe Spinach Dip: Chopped spinach simmered with sour cream, spices and seasonings blended with four creamy cheeses. Served with fresh salsa and tortilla chips.

Chicken fajita Quesadilla: Hand stretched and butter grilled tortillas



loaded with fajita chicken, Jack and Cheddar cheeses, bacon and Pico de Gallo.

Triple Treat Sampler: Combination platter of Beef, Beans and Cheese Nachos and your choice of two: Crisp Potato Skins, Chicken Tenders or Mozzarella Cheese Sticks.

Crazy Nachos: A large platter of nachos loaded with fajita chicken or seasoned ground beef, refried beans, Jack and Cheddar cheeses,

jalapeños and tomatoes.

Some notable Salads & Soups: Hawaiian Chicken Salad

A large marinated chicken breast, char grilled, sliced and served on a bed of fresh salad greens with Pico de Gallo, pineapple, tortilla strips and honey lime dressing.

Baked Potato Soup

Their signature soup topped with grated cheese and bacon.

For Fish, Shrimp or chicken try one of: Key West Chicken & Shrimp:

A marinated, grilled chicken breast

topped with large grilled shrimp and our pineapple Pico de Gallo. Served on a bed of seasoned rice with two side dishes.

Tilapia with Mango Salsa:

Grilled Tilapia topped with Mango Salsa and Blackened Shrimp, Served on a bed of seasoned rice with two side dishes.

Fresh Cold Water Salmon:

Grilled, blackened or bourbon glazed salmon served on a bed of seasoned rice with two side dishes. Other items on the menu include Honey barbeque baby back ribs,

Beer battered fried shrimp, oven

baked chicken pot-pie, Fresh water catfish, Grilled chicken Alfredo.

Monte Cristo: Roast Turkey and hickory smoked ham with two cheeses on fresh bread, battered and lightly fried, with raspberry preserves. A variety of burgers include Smokehouse burger and Pepper/Ranch burger and a selection of Steaks are also available.

Don't forget to check out the Ultimate Lunch Combo:

Bowl of Soup & House Salad & Loaded Baked Potato Half of Double Decker Club & Caesar Salad.

Also there are always lunch specials like Fish & chips with coleslaw for \$8.95

Whatever the occasion hopefully you will find Cheddars a refreshing change from the typical franchise restaurant.



AEROSCRAFT - Imagine Flying in the next 5 years



The company now known as Worldwide Aeros Corporation started out as Aeros, Ltd., a small company founded in the Ukraine by Igor Pasternak. After growing up in the city of Lviv, Ukraine, Pasternak received a Masters degree in engineering from Lviv Politechnike. After achieving success with Aeros, Ltd. in developing and marketing lighter-than-air craft in Europe and Asia, Pasternak moved the company to New York in 1992 and later to California. In 2005 he started to design Aeroscraft to be built on the basis of a new concept in flight. A prototype should be finished by 2010

A new paradigm in air transport is born with the advent of the Aeroscraft - an aircraft that utilizes adjustable buoyant and dynamic lift, creating unique capabilities beyond what is available from any other air platform today.

Even though the Aeroscraft dwarfs the largest commercial airliners, it requires less net space on the ground than any plane because it doesn't need a runway. It takes off and lands like a helicopter, straight up and down.

This is not a Blimp. It's a sort of flying Queen Mary 2 that could change the way you think about air travel. It's the Aeroscraft, and when it's completed, it will ferry pampered passengers across continents and oceans as they stroll leisurely about the one-acre cabin or relax in their staterooms.

Unlike its dirigible ancestors, the Aeroscraft is not lighter than air. Its 14 million cubic feet of helium hoist only two-thirds of the craft's weight. The rigid and surprisingly aerodynamic body, driven by huge rear-ward propellers, generates enough additional lift to keep the behemoth and its 400-ton payload aloft while cruising.

Its overall size equals to two-football-fields-long. During takeoff and landing, six turbo-fan jet engines push the ship up or ease its descent.

Pasternak says several cruise ship companies have expressed interest in the project and for good reason - the craft would have a range of several thousand miles, and, with an estimated top speed of 174 mph, could traverse the continental United States in about 18 hours.

The company envisions a cargo-carrying version that could deliver a store's worth of merchandise from a centralized distribution center straight to a Wal-Mart parking lot, or, because the helium-filled craft will float, a year's worth of supplies to an offshore oil rig. 'You can land on the snow, you can land on the water, 'Pasternak says. 'It's a new vision of what can be done in the air.'

Operating the Aeroscraft

The Aeroscraft can take off and land vertically using six <u>turbofan</u> jet engines, thanks to an emergent technology called Dynamic Buoyancy Management. This capability will allow it to fly to and from areas without an extensive transportation infrastructure. Once the craft reaches cruising altitude (around 8,000 feet), giant aft propellers will move it forward, and the Aeroscraft's aerodynamic shape will generate enough lift to keep it in the air.

To minimize noise, the aft-mounted propellers will be electric, powered by a renewable source such as hydrogen fuel cells. Sophisticated buoyancy - management system will serve the same purpose as trim on an airplane, allowing for precise adjustments in flight dynamics to compensate for outside conditions and passenger movement. This means the Aeroscraft will be both efficient and quiet.

The automated system will draw outside air into compartments throughout the ship and compress it to manage onboard weight. On a pressurized plane, windows like these would explode outward. The Aeroscraft would not fly high enough to need pressurization.


