of us are familiar with those people who think that rules are made to be broken. Board members have gotten reputations as "Condo Commandos" for merely enforcing the rules that our residents have asked for.

ALL of the owners and lessees in our complex have the same rights. They also have the same obligations. The FIRST, and most important, is do nothing to injure your neighbor. Injury does not mean hurting someone physically. It can mean demeaning their property value, creating a hostile environment, or intimidating someone to the point of panic. We have seen

all of these things occur in the last 6 months. It's time for Royal Park to stand up for itself and say NO MORE!!!!

We have videotapes of one of our resident's ADULT children putting a puppy on the pool tables. We have videotapes of some of our residents drinking, destroying property, and creating havoc in our clubhouse. As I write this, I am watching some young adults roller-blading between parked cars, although it's a banned activity here. They're throwing a football. There is a rowboat parked in the complex. The owner told the gate guard that he was dropping his passenger off. He lied.

Dumb things, right??? No, not really. Most of our residents have invested a good deal of money in their apartments. They did it because they were assured that it would not become "Tobacco Road", where anything goes. The board is REQUIRED to see that the rules and regulations governing our association are enforced. To neglect that duty is to make the board members personally liable. SORRY CHARLIE, I'm not about to be sued because of lack of fiduciary responsibility.

So, now it's up to you, the association members, to insist that the rules and regulations are not just words in a booklet. YOU, let me repeat, YOU, are the only ones who can turn Royal Park back into the community that we bought into. You're angry about a lot of things, and rightfully so, but YOU MUST DO YOUR PART!!!

Why is it that you can INSIST that the board "Do Something", but are afraid to say to your neighbor, "Please don't do that"??? The board is not a police department. You ALL must help to protect your property. Tell the board what you want it to do. Then, stand behind the board when they do what you asked. If you have a complaint, PLEASE, put it in writing. NO ONE will know who complained, unless it winds up in court, BUT, the board, legally, can only act on WRITTEN complaints. We have 15 and 16 and 17 year old kids, and yes, even 19, 20, and 21 year olds wreaking havoc in our community, and YOU ARE AFRAID!!!! How are we going to fix it?

Step number 1. We can insist, and yes DEMAND that everyone abide by the rules. What that means is, that you will NOT be able to ask your favorite board member to IGNORE a violation, because, "Oh, they're nice people". Florida law requires that rules and regulations be enforced UNILATERALLY, without regard to race, creed, color, sexual orientation, or they're related to the board president, VP, or secretary. The rules govern ALL of us.

No resident should have to pay to have his neighbor's old furniture or appliances removed, yet, if we have to have the city remove it. that's what happening. Nor do we want the dumpster rooms filled with old furniture, appliances, etc.. Residents are complaining about items left near the maintenance shed. Give us a few weeks to work on this. Meanwhile, watch out for your neighbor, help someone if you can, and remember, this life is all we have. Enjoy it, share it,

Please be aware that the Association has the right to tow, according to your documents. They have no obligation to inform you of these intentions. Consider yourself forewarned that if your vehicle or your guests vehicle is illegally parked, in poor repair, on the property illegally or not properly registered, it will be towed. We must have order in Royal Park and everyone must be treated the same. The Association takes no pleasure in towing vehicles, so please know and comply with all parking restrictions.

Who's Who at the Gatehouse

By now you have probably noticed that the way we are handling "security" has changed. Allied Security was discharged two months ago as they were unable to give us people who could do the job. The guard shack is now called the GATE-HOUSE. The uniforms now have a new look and we have security cameras installed in the clubhouse. Many people have questioned how much all of this cost Royal Park. Nothing. Well, at least not a penny more than you paid for Allied. Please try to show patience and courtesy to the employees. This can be a very busy job and it isn't always possible to drop everything and take care of your needs. There will be some changes made to improve our ability to control who comes in and out of Royal

Park. Please don't be resentful of the changes; they are for everyones benefit. Leaning on the horn at the gate or being rude to a supervisor, accomplishes nothing. Effective August 30, the following rules will be enforced.

- (1) You will be required to stop at the Gate stop sign. Shooting the gate without being acknowledged will not be tolerated.
- (2) When calling in a guest, you must give your building and apartment number, your first and last name and your guest(s) first and last name.
- (3) The called in Guest must show photo ID.
- (4) If you are being dropped off by a friend, please have your ID ready.
- (5) If you leave Royal Park on foot, you must have a photo ID to get back in. Anyone attempting to gain access on foot without an ID, the police will be called for trespassing.

There are several residents in Royal Park who are blind or otherwise handicapped. Many of the changes in Royal Park are a hard-
