# Real Estate Realities: Part IV

Fall is here and as the winter approaches we see an influx of visitors, tourists, and "snow birds." In this article I will discuss facts about Broward County for the benefit of those who are thinking of making their homes or relocating here.

BROWARD COUNTY has 23 miles of Beaches, 230 days of sun, and 3,000 hours of sunshine annually. Average temperature is 76 Degrees. Total area is 1,285 square miles, of which 438 square miles are buildable. There are 300 miles of inland waterways. No wonder Fort Lauderdale is known as the Venice of Florida.

BROWARD COUNTY has a population of 1.2 million with 2,500 restaurants, 30,000 hotel rooms, 288 parks, 75 golf courses and 550 tennis courts. It is also the home of the \$52 million Broward Center of Performing Arts, home of a \$50 million Convention Center and also the home of Port Everglades-world's largest and most used five-star cruise port.

There are approximately 589,500 parcels of real property in Broward County of which 255,500 are single-family homes and 235,000 are condominiums and cooperatives.

ROYAL PARK CONDOMINIUM Complex is located in Oakland Park which is almost the center of Broward County on the north & south axis. Royal Park is located close to major arteries and yet only 10 minutes from the beach. Amenities include 24 hour gated security, 3 heated pools, clubhouse and car washing facilities, making it one of the most desirable and affordable places to live. Royal Park is like an island surrounded by a canal as a moat with the lush Easterlin Park on one side and a community park with lake across from its entrance. Royal Park has beautifully landscaped grounds with picnic and barbecue areas and ample spaces for guest parking. The Clubhouse boasts her and his exercise rooms, saunas and steam rooms. It also has pool tables, card rooms, library, work-studio, bingo and dance hall. There is also an entertainment room with bar and kitchen areas which can be used by residents for private parties and functions.

Taxes for Royal Park are one of the lowest in Broward County; for example: 2 bedroom units with homestead exemption has on average \$150.00 or less and 1 bedroom units has \$20.00 or less tax for the entire year!!!

### City Watch

The city commission meetings are starting to be like old times. One commissioner, standing up for family values and saving money, has DENOUNCED recycling, refused to support EARTH DAY, and is, generally, against everything that Royal Park is for. He DOES NOT want the weight based system. He feels, that if businesses pay their fair share, (at Royal Park's expense), that they might move out of the city. I say that they've had a free ride long enough!!! We should pay for what we use, be it water or trash removal. Most of our residents are living on social security. Why should WE PAY TO HAVE THEIR TRASH REMOVED??? Do you agree??? Then please come to the commission meeting on October 18. Stand up for your dollars!!!

Our water bills will be going UP by \$672.00 a month next year. This will be to pay for putting in storm sewers in the city. We are already paying \$1,344.00 monthly for storm sewers, but the state has mandated a more comprehensive plan. Hopefully, we'll eliminate the large pools of water at our entrance, and on Powerline at Oakland, and on the short-cut on 10th Terrace. Since the plan has already passed, it's up to us to lobby to see that they complete the projects that affect us FIRST. Again, come to the meetings and SPEAK UP!!!

Slowly, but surely, our recycling bins are being repainted. (No Malvena, I didn't forget). This is another benefit of a city run trash removal service. We all have to understand that WE are a powerful political force. All we have to do is exercise that power. Out of 671 units, only Barbara Carlon and myself showed up, from Royal Park, at the October 4th meeting. Believe it or not, that sends a message to the city. And the message is, THEY DON'T CARE ENOUGH TO VOICE THEIR OPINION. The squeaking wheel will get the oil. So, GET IN THERE AND SQUEAK!!!

### Cancer Fighting Recipe by an Internet Chef

RICE AND GREENS

Prep: 5 min Cook: 27 min Cost per Serving: 36 cents

1 slice bacon, cut in 1/2-inch pieces

- 1 cup chopped onion
- 2 1/2 cups chicken broth
- 1 box (10 ounces) frozen collard, turnip or mustard greens, or kale, not thawed
- 1 1/4 cups uncooked converted long grain white rice
- Put bacon and onions in a 2-quart microwave-safe bowl. Microwave uncovered on high 3 to 4 minutes, stirring once, until bacon is crisp and onion translucent.
- Add chicken broth and greens. Cover with lid or vented plastic wrap.
   Microwave on high 4 to 5 minutes, until greens are thawed enough to separate.
   Stir in rice. Cover and microwave on high 16 to 18 minutes, stirring once, until rice is tender and all liquid is absorbed.
- \* Serves 6. Per serving: 199 cal, 6 g pro, 37 g car, 3 g fat, 3 mg chol, 462 mg sod. Exchanges: 1 3/4 starch/bread, 2 vegetables, 1/2 fat.



that our residents might enjoy, if only the opportunity was presented. At our next board meeting, we'll discuss it, and ask for a volunteer, or volunteers. If you have the time and energy, please think about it.

Second item: The budget committee has been working diligently to prepare the budget for 1996. Please keep an open mind, remembering that our insurance rates have taken a 300% increase. It will be a bare bones budget, but please, thank those that did give of their time to help put it together. Facts are facts, and, believe it or not, there was no fighting. Kind of shocked resignation. The budget will reflect what it's going to cost to maintain our property, no more, no less.

Third item: Common courtesy. We don't want "Condo Commandos" in Royal Park. However, someone must take the bull by the horns when some residents flaunt their rule violations in their neighbors' faces. Come on folks, just treat everyone as you would like to be treated. BUT also remember, that this is not your PRIVATE home. We have rules here, and most of us bought into Royal Park because of the rules. Blowing horns, blasting radios, and intoxicated brawling is not what most of the people who live here are expecting. We all understand that children play, and generally are louder than most adults. Most of the adults in here were children at one time!!! Please supervise your children, and by the same token, please understand that a child riding a bike is not a reason to call security, they're kids, and kids do ride bikes. Parents, if you feel that your children are old enough to be on Royal Park grounds un-supervised, remember that the rules don't allow it. So, consider Royal Palm Park, directly across the street, where ball playing is not only allowed, but encouraged.
